

Combined FEIF Sport Judges and Trainer/Instructor Seminar

24th-26th of March 2023, Reykjavík, Iceland

Join us in Iceland for an exciting full weekend of events! High level competitions and shows with both great professionals and students of Hólar will give us the opportunity to put new theoretical knowledge about shape, biomechanics and movements and the rider's influence on them (connection) into practice for both judges (Sport Judge Guidelines & relevant firewalls) and trainers/instructors (education and guidance of their pupils).

The seminar (combined Sport Judges and Trainer/Instructor seminar) will be held at the Fákur facilities in Reykjavík, Iceland. The programme will include presentations, lectures, demonstrations and masterclasses as well as the Grand Show of Fákur on Saturday evening with some of Iceland's best horses and riders.

0900-1200 World Championships 2023 judges ONLY – mandatory seminar

1300 -1700 will include an overview of some central scientific studies concerning the main theme of the seminar. Also some horses will be looked at outside, filmed and discussed afterwards.

1900 5-gait competition in Sprettur (1st hour mandatory, the rest is optional)

Saturday, March 25, 2023

0900-1730 The Day starts with a presentation by Þorgeir Guðlaugsson about "Duty Factor and what it can tell us about slow tölt".

After that we'll join the Education Day in Fákur with Demonstrations from both 3rd year Hólar students as well as known professionals in the field. Education of the riding horse shown in various ways. Discussions on the main themes of the seminar during and afterwards.

Evening Fákur's big annual show (non-mandatory attendance) with amazing horses and riders and plenty of fun.

Sunday, March 26, 2023

Wrap up of the previous days, discussions, and conclusions.

End of the seminar: 12:00



The entire seminar will be held in English and is both theoretical and practical.

Eligible participants:

International FEIF Sport Judges and Trainers/Instructors registered on the FEIF matrix list have priority. Interested persons not listed as International FEIF Sport Judge or as Trainers/Instructors on the FEIF matrix can register for the waiting list and will receive confirmation of a seat by February 1st, 2023. Waiting list places will be distributed in the order of registration.

The maximum number of participants is limited to 80 participants, which will be spread between Sport Judges and Trainers/Instructors. As soon as the maximum number of participants (has been reached, the registration for the seminar will close. (Quota: 50%:50% for judges and trainers/instructors)

License:

Judges with a FEIF license have to attend at least one full FEIF Sport Judges Seminar in the three years period before the expiration date of their license and have to be an active judge for at least 15 days at WorldRanking events in this period. For judges with a FEIF license with an expiration date of December 2023, this seminar is their last chance to renew their license if they didn't attend the required seminar earlier. The Board of FEIF has decided to have the second seminar per judges for free every three years (the license period). The offer includes the seminar fee plus food and included beverages, but not hotel rooms, transport or side programme. Registration for the seminar using the free option is only possible **until December 31, 2022**.

As far as FEIF is concerned, this seminar should count for the purpose of continuous professional development for Trainers/Instructors which are licenced in their national association - but please check with your national organisation.
